The National Cancer Patient Experience Survey is undertaken by Quality Health on behalf of NHS England



## Introduction

The National Cancer Patient Experience Survey 2015 is the fifth iteration of the survey first undertaken in 2010. It has been designed to monitor national progress on cancer care; to provide information to drive local quality improvements; to assist commissioners and providers of cancer care; and to inform the work of the various charities and stakeholder groups supporting cancer patients.

The survey was overseen by a national Cancer Patient Experience Advisory Group. This Advisory Group set the principles and objectives of the survey programme and guided questionnaire development.

The survey was commissioned and managed by NHS England. The survey provider, Quality Health, is responsible for designing, running and analysing the survey.

Note that a number of significant changes were made to the 2015 survey so caution should be taken in directly comparing data from the 2015 survey to the findings of the previous CPES surveys. No comparisons with previous surveys are presented in this report.

## This report

The report shows how this CCG scored for each question in the survey, compared with national results. It is aimed at helping individual CCGs to understand their performance and identify areas for local improvement.

Note that responses for questions with 1-20 respondents have been suppressed. This is to protect patient confidentiality and because uncertainty around the result is too great.

## Data tables

The data tables presented in this report show the following for each question:

- **Column 1** shows the number of respondents to this question
- **Column 2** shows the unadjusted 2015 score for this CCG
- **Column 3** shows the case-mix adjusted 2015 score for this CCG
- **Column 4** shows the lower limit of the expected range of scores for this CCG (the top of the pale blue section on the Comparability chart - see below)
- **Column 5** shows the upper limit of the expected range of scores for this CCG (the bottom of the dark blue section on the Comparability chart - see below)
- **Column 6** shows the National Average score for this question.

Results for individual response options are presented in the detailed data tables [www.ncpes.co.uk](http://www.ncpes.co.uk)  
Confidence Intervals for unadjusted and case-mix adjusted data are provided in these tables.

Expected ranges and 95% Confidence Intervals highlight the uncertainty around the results. The size of the expected ranges and confidence intervals will be different for each question, and depends on the number of respondents and the range of their responses.

For further details on case-mix adjustment and the scoring methodology used, please refer to the Annex.

### **Comparability charts**

For the 2015 survey, we have adopted the CQC standard for reporting comparative performance, based on calculation of "expected ranges". This means that CCGs will be flagged as outliers only if there is statistical evidence that their scores deviate (positively or negatively) from the range of scores that would be expected for CCGs of the same size.

The Comparability charts in this report show a bar with these expected ranges (in grey), higher than expected (in dark blue), and lower than expected (in pale blue). A black dot represents the actual score of this CCG.

The same colour convention has been used in Column 3 of the Data tables.

### **Tumour group tables**

The final set of tables in this report show the scores for each question for each of the 13 tumour groups, with a comparative national score for that tumour group.

These breakdowns are intended as additional information for CCGs to understand the differences between the experiences of patients with different types of cancer. The numbers are generally relatively small and may not be statistically significant. They should therefore be treated with some caution.

### **Notes on specific questions**

Question 5 in the survey has not been scored. However, the unscored data is useful and has been published alongside the other results in this report. This question asked respondents to "tick all that apply". The results show all of the responses given including where respondents chose two or more options.

Questions used to direct respondents to different parts of the survey (questions 4, 17, 24, 27, 40, 43, 46) and other demographic and information questions are not reported.

## **How to use the data**

Unadjusted data should be used to see the actual responses from patients relating to the CCG.

Case-mix adjusted data, together with expected ranges, should be used to understand whether the results are significantly higher or lower than national results.

Case-mix adjusted data, together with (case-mix adjusted) Confidence Intervals (presented in the detailed data tables [www.ncpes.co.uk](http://www.ncpes.co.uk)), should be used to understand whether the results are significantly higher or lower than the results for another CCG.

## **Response rates**

Numbers of respondents by tumour group, age and gender can be found in the Annex.

## Executive Summary

Asked to rate their care on a scale of zero (very poor) to 10 (very good), respondents gave an average rating of **8.8**.

The following questions are included in phase 1 of the Cancer Dashboard developed by Public Health England and NHS England\*:

- **76%** of respondents said that they were definitely involved as much as they wanted to be in decisions about their care and treatment
- **86%** of respondents said that they were given the name of a Clinical Nurse Specialist who would support them through their treatment
- when asked how easy or difficult it had been to contact their Clinical Nurse Specialist **91%** of respondents said that it had been 'quite easy' or 'very easy'
- **87%** of respondents said that, overall, they were always treated with dignity and respect they were in hospital
- **94%** of respondents said that hospital staff told them who to contact if they were worried about their condition or treatment after they left hospital
- **63%** of respondents said that they thought the GPs and nurses at their general practice definitely did everything they could to support them while they were having cancer treatment.

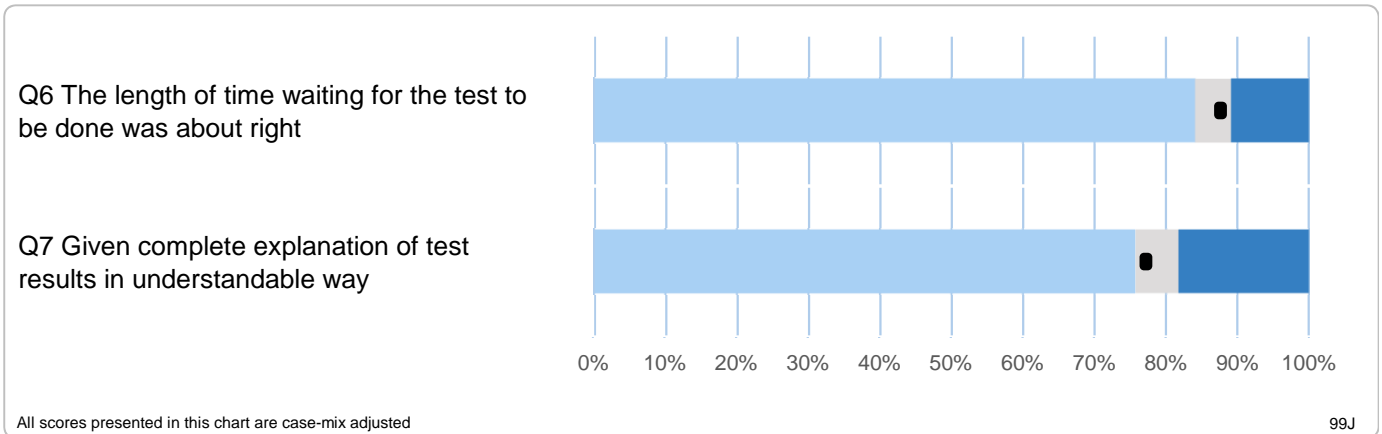

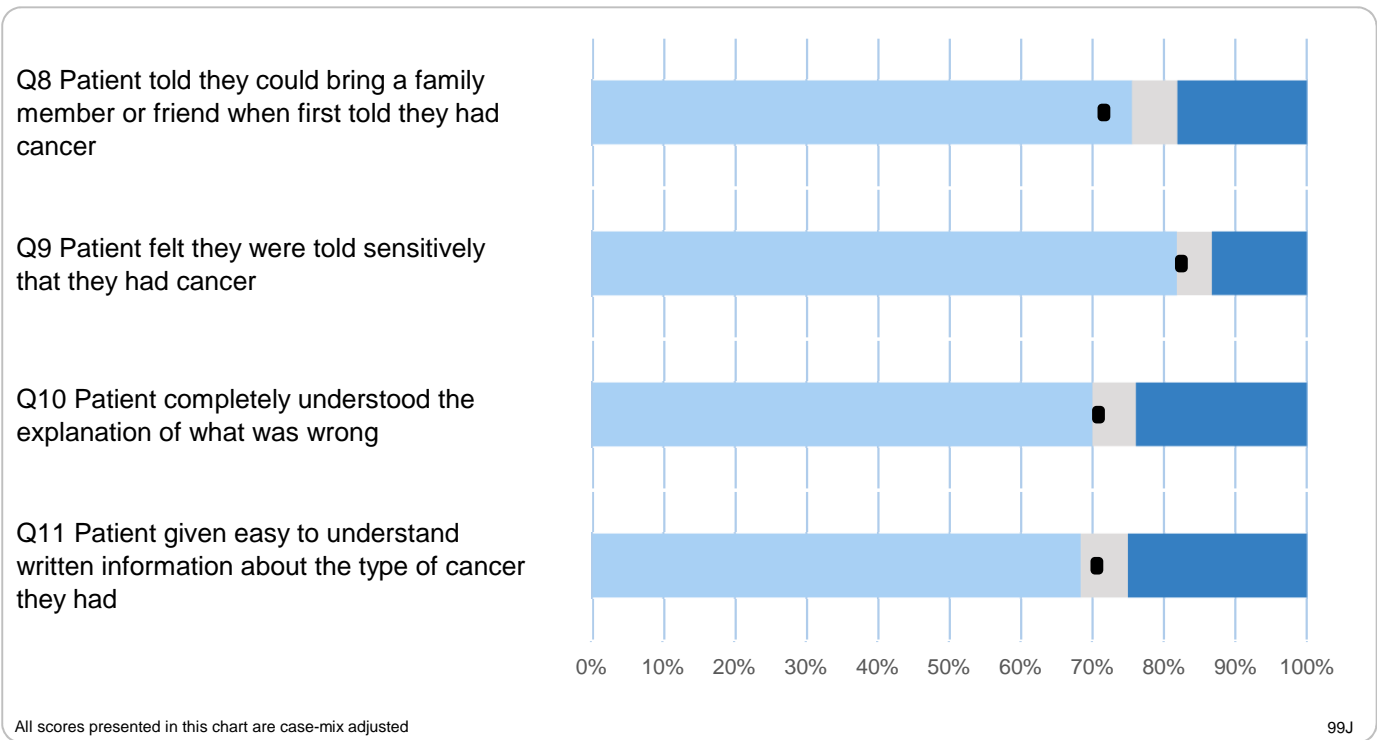

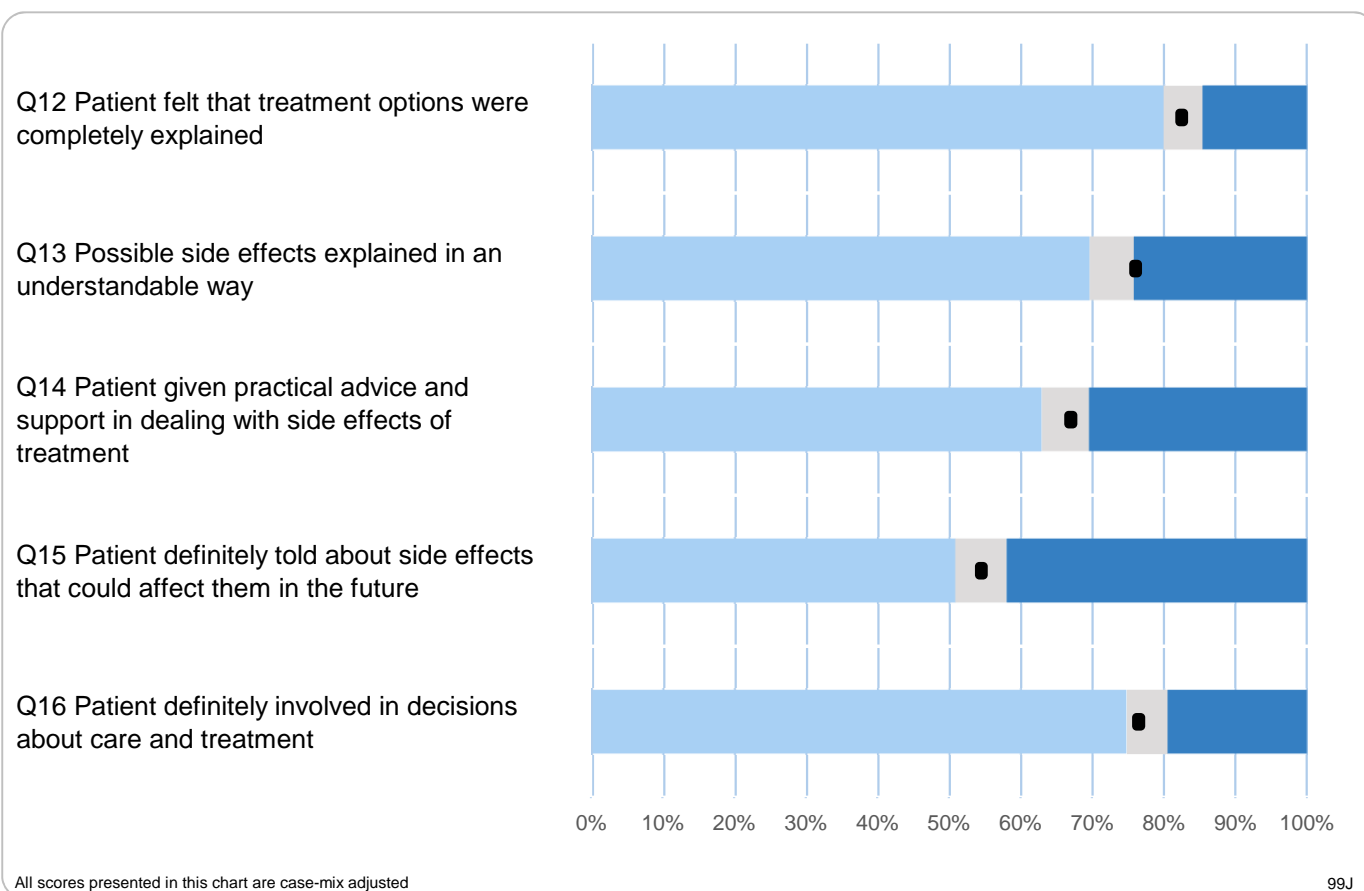

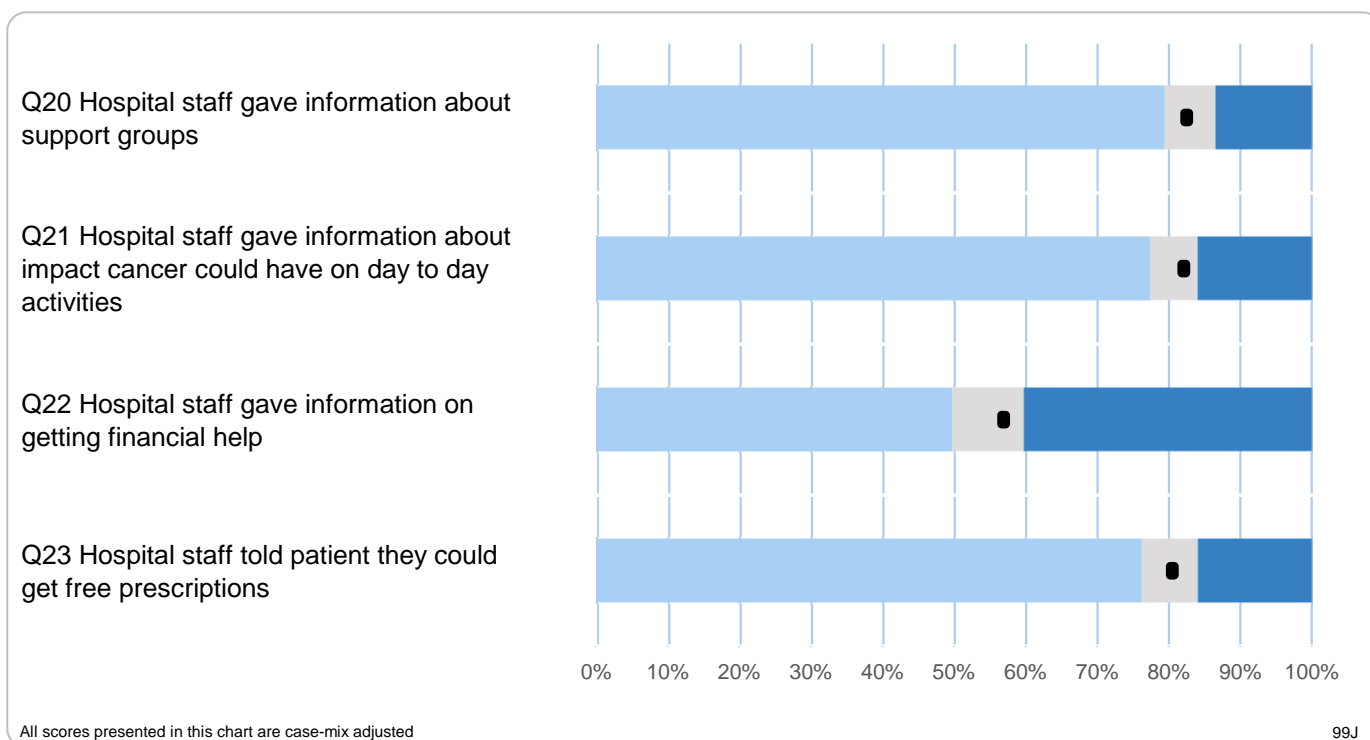

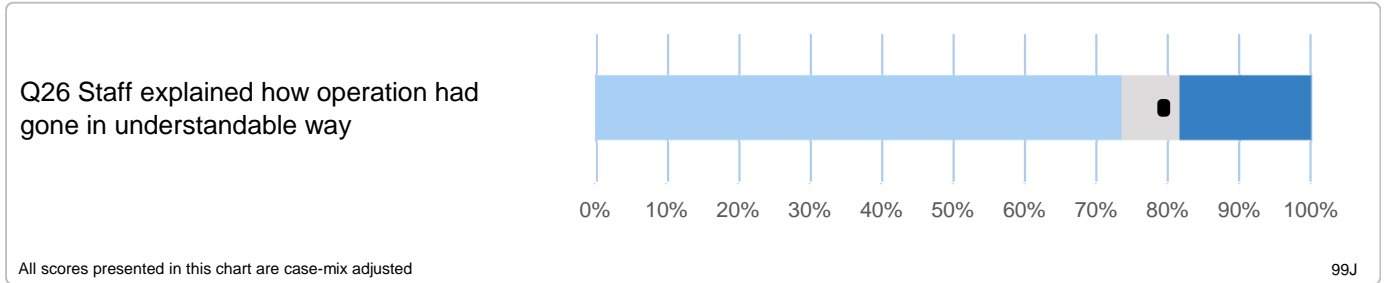

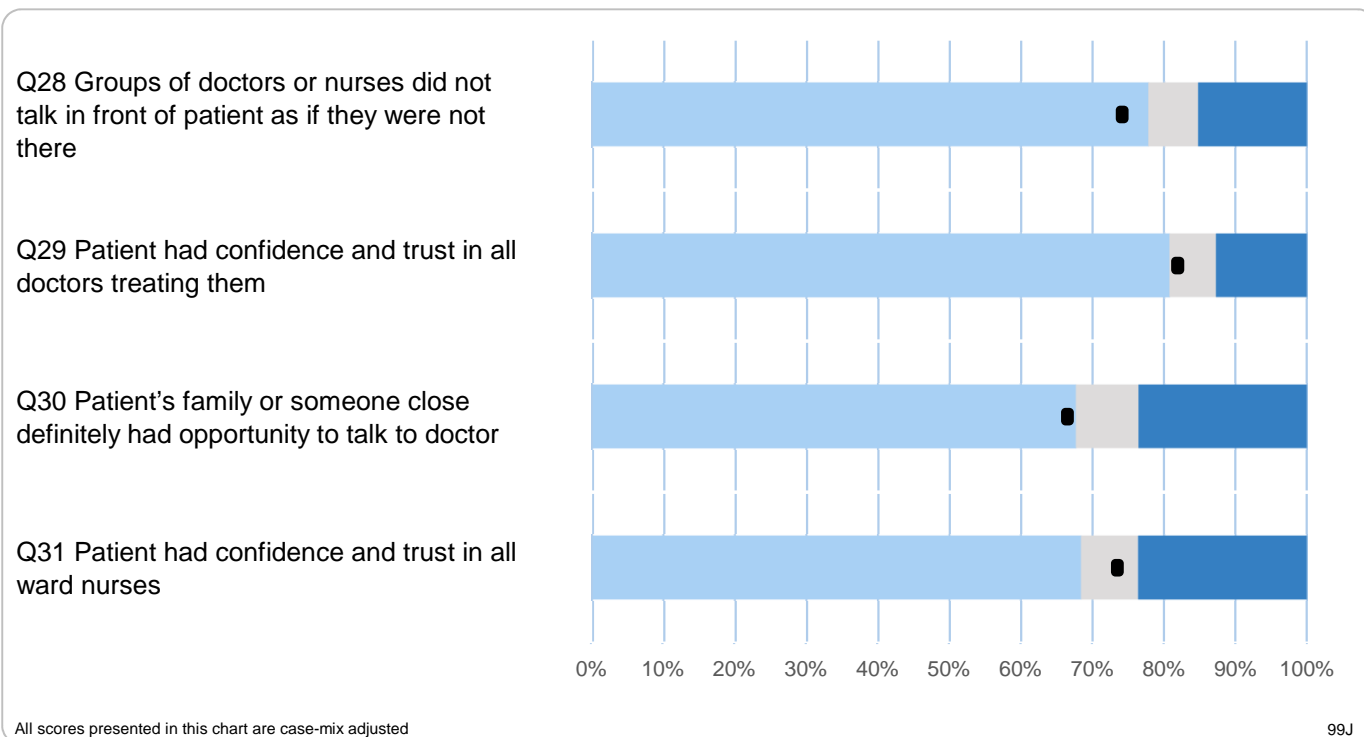

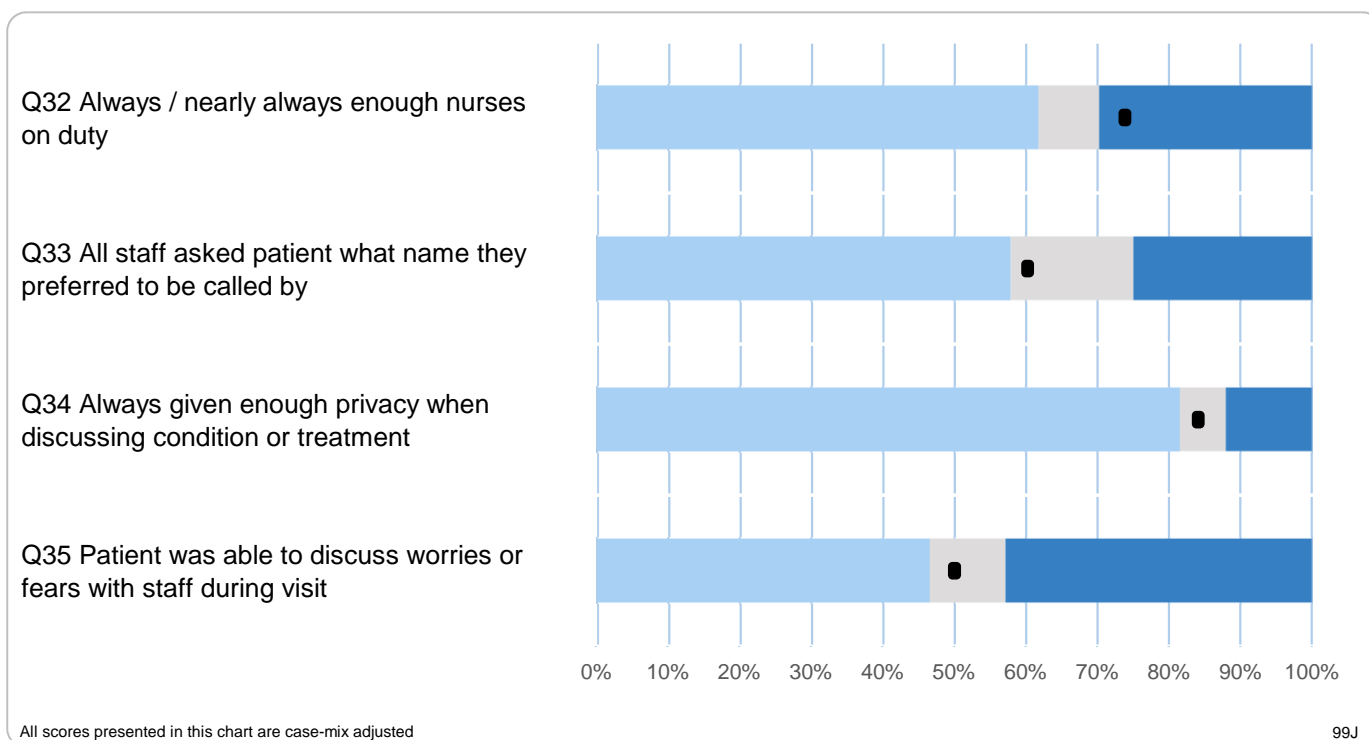

Hospital care as an inpatient (Part 1 of 3)



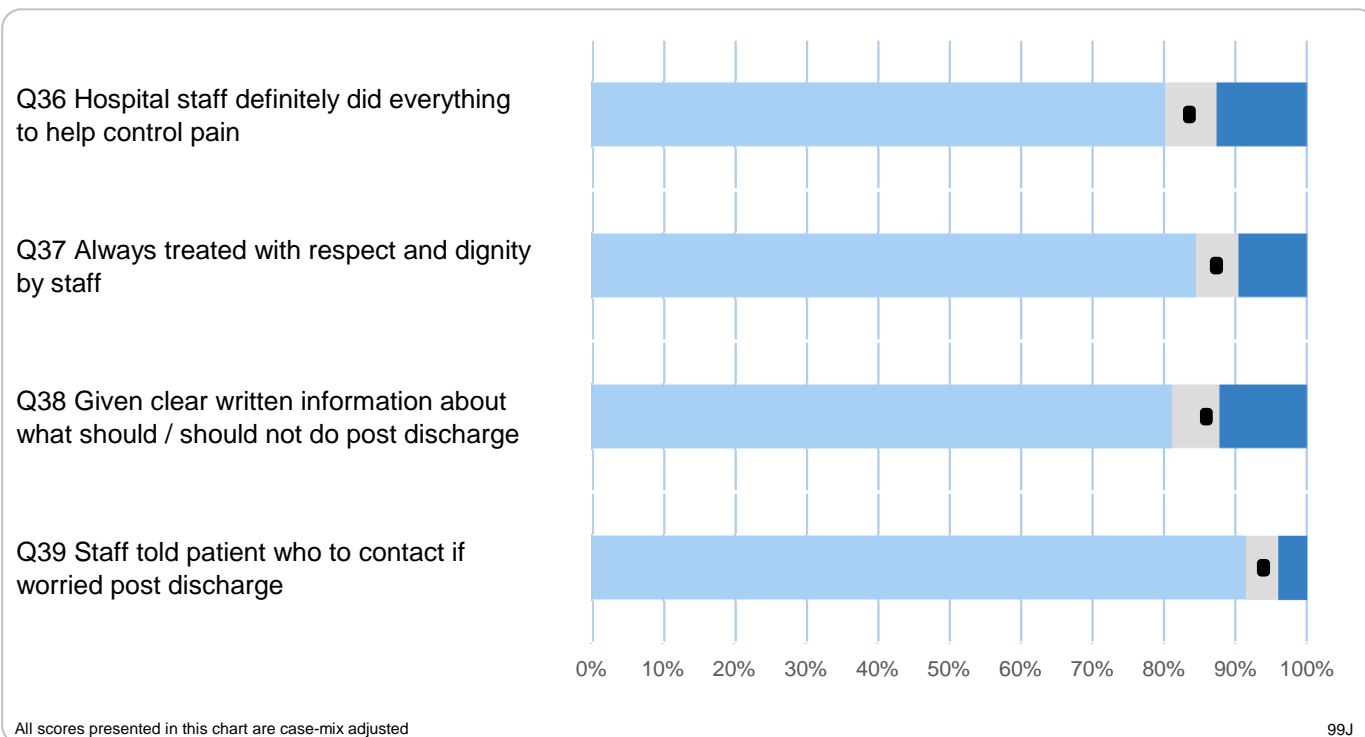

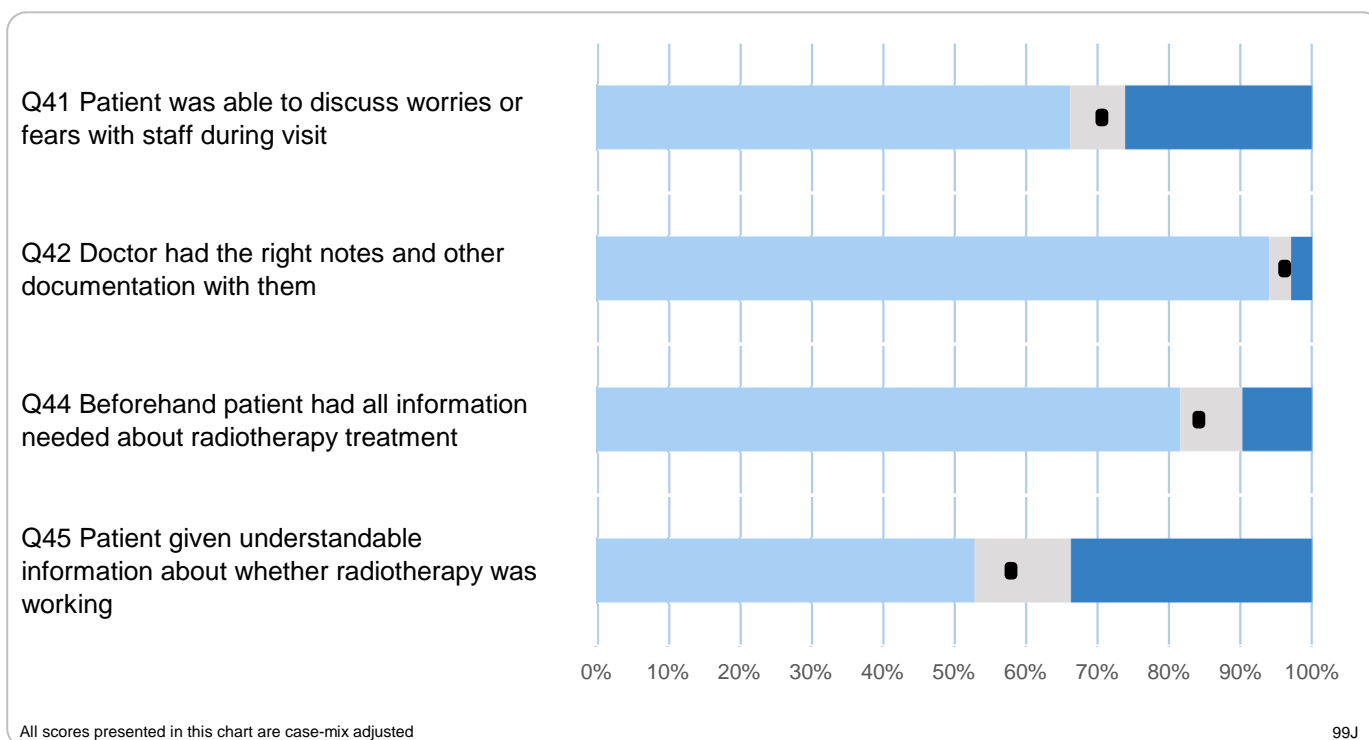

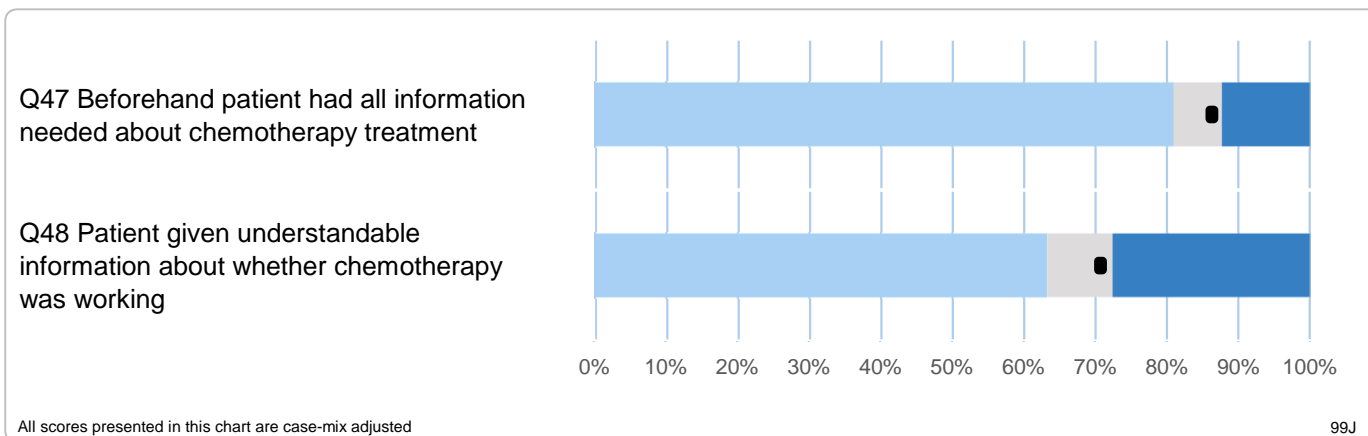


Hospital care as a day patient / outpatient (Part 1 of 2)



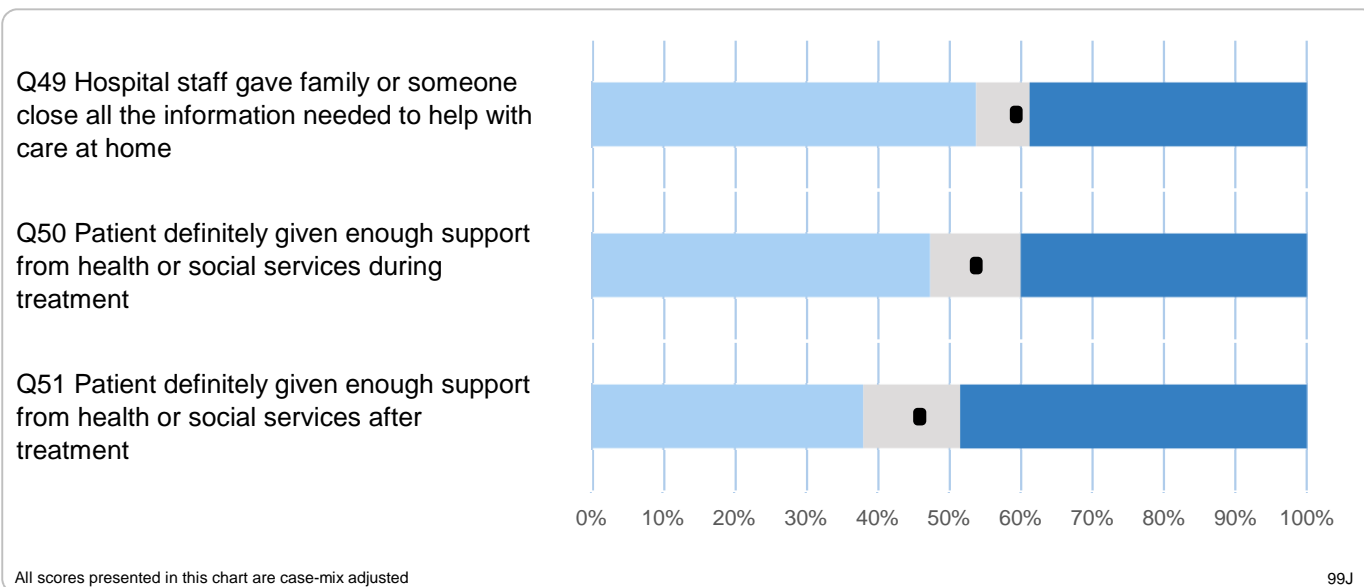

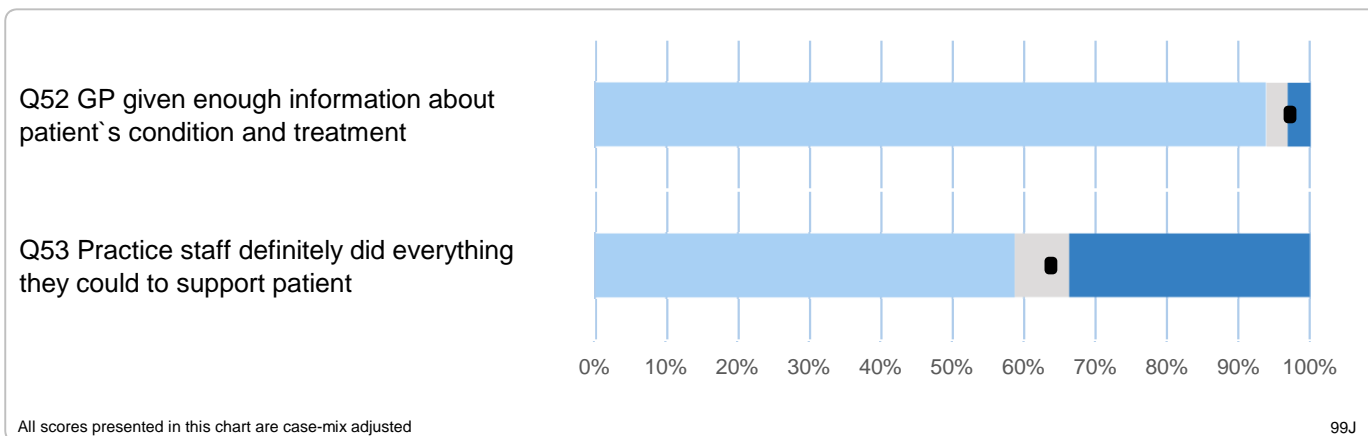

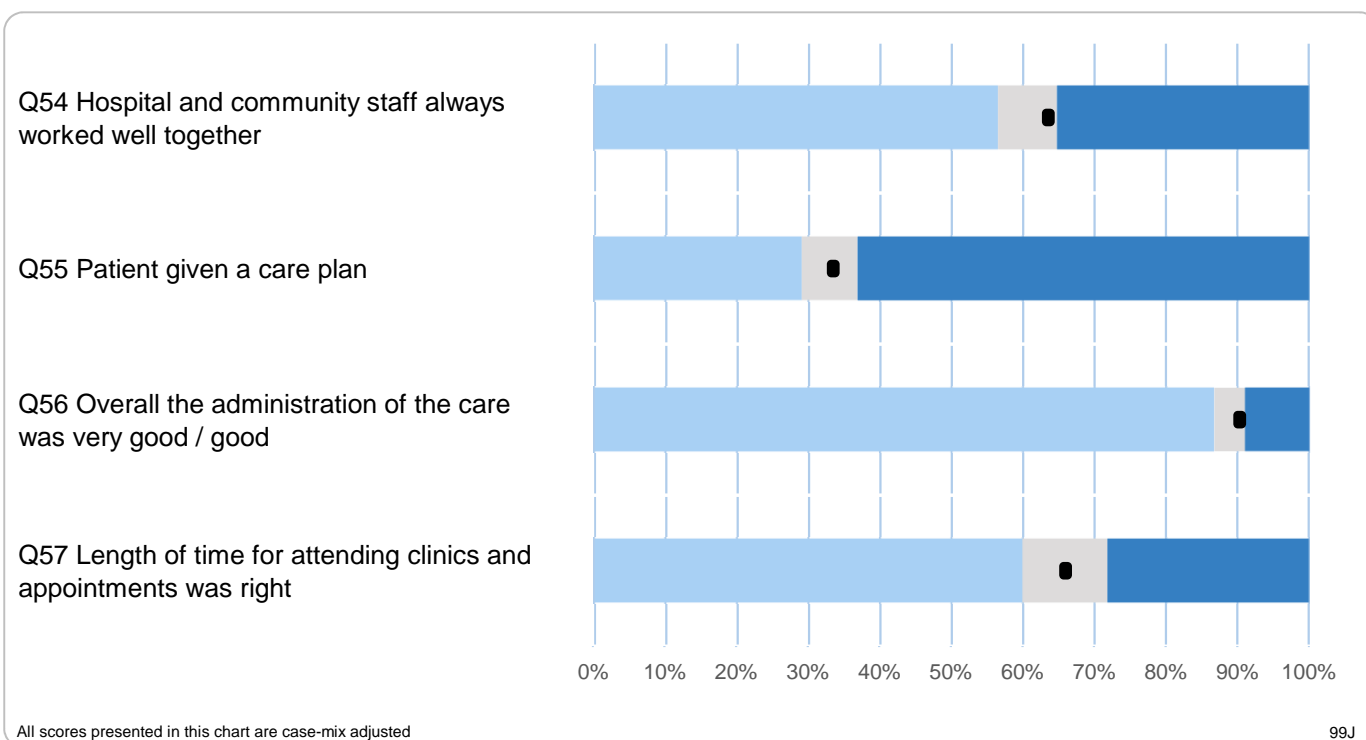

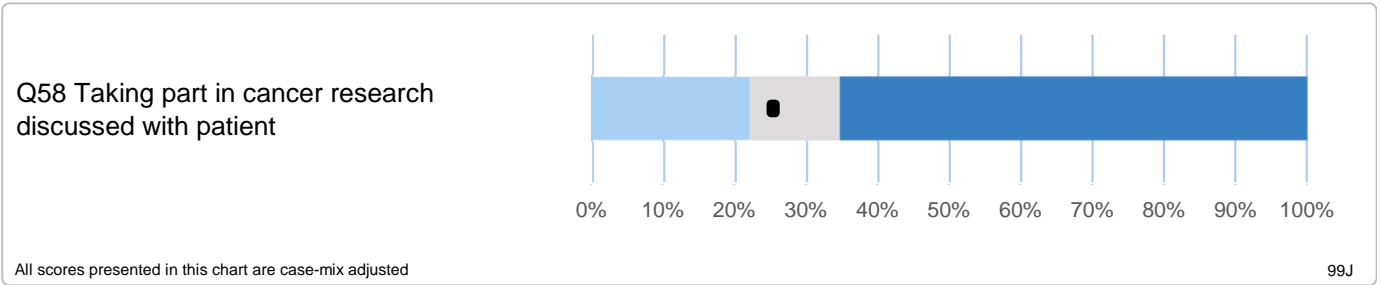

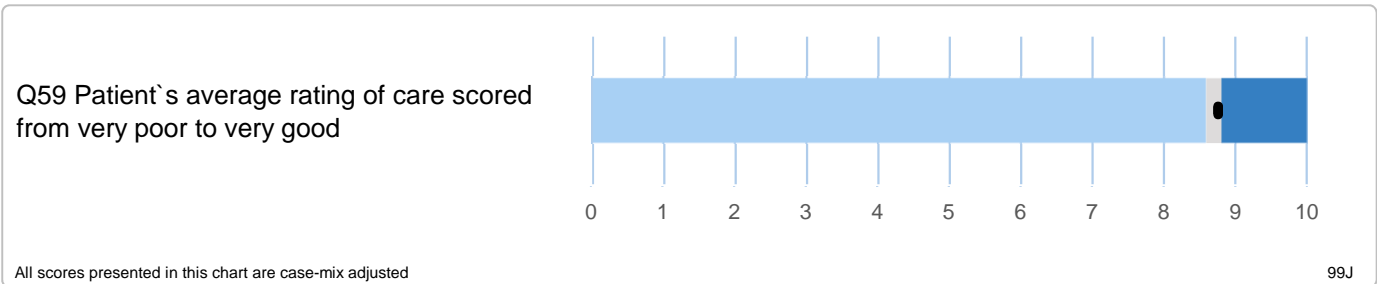

## **Annex**

### **Methodology**

The sample for the survey included all adult (aged 16 and over) NHS patients, with a confirmed primary diagnosis of cancer, discharged from an NHS Trust after an inpatient episode or day case attendance for cancer related treatment in the months of April, May and June 2015.

The patients included in the sample had relevant cancer ICD10 codes (C00-99 excluding C44 and C84, and D05) in the first diagnosis field of their patient records, applied to their patient files by the relevant NHS Trust, and were alive at the point at which fieldwork commenced. Deceased checks were undertaken on up to three occasions during fieldwork, to ensure that questionnaires were not sent to patients who had died since their treatment.

Trust samples were checked rigorously for duplicates and patient lists were also de-duplicated nationally to ensure that patients did not receive multiple copies of questionnaires.

The fieldwork for the survey was undertaken between October 2015 and March 2016.

For the first time, the survey used a mixed mode methodology. Questionnaires were sent by post with two reminders where necessary, but also included an option to complete online. A Freephone helpline was available for respondents to ask questions about the survey, to enable them to complete their questionnaires over the phone, and to provide access to a translation and interpreting facility for those whose first language was not English.

The Health Research Authority supported the survey by granting Section 251 approval.

## **Redevelopment of the 2015 survey**

A number of significant changes have been made to the National Cancer Patient Experience Survey in 2015:

- the length of the questionnaire has been reduced
- response options have been reviewed and changed to make them consistent throughout the survey
- some of the questions and / or answer options have been changed so that they are now in line with questions in other patient surveys (e.g. the Care Quality Commission national patient surveys), to improve comparability between them
- the topic areas within the questionnaire have been redesigned to capture the whole patient journey.

There are 50 questions in the questionnaire that relate directly to patient experience. Of these, 14 remain unchanged from previous years; and a further 21 have been slightly amended. We draw caution in directly comparing data from the 2015 survey to the findings of the previous CPES surveys, even for identical questions. Changes in the structure of the survey instrument (questionnaire) and also the administration of the survey (calendar period and length of time from sampling to field work start and completion) may influence nationwide averages, although these features will not greatly impact on relative comparisons (e.g. between patient groups or hospitals).

The other 15 questions are either new or substantially changed from previous years.

It is expected that there will be few, if any changes, to the questionnaire going forward so we will be able to compare the results year on year. Where changes are necessary they are expected to be for methodological reasons or to improve question reliability.

Another significant change in 2015 is that an online version of the questionnaire has been developed. The online version was developed to make the questionnaire more accessible for respondents. This may have an impact on the demographic characteristics of the respondents. This may be an improvement if previously underrepresented groups have responded. However, changes to the demographics of respondents may have implications on the overall results - and again, leads us to draw caution in directly comparing results with previous years.

## **Official Statistics**

The 2015 survey data has been published for the first time as Official Statistics. The 2015 survey data has been produced and published in line with the Code of Practice for Official Statistics.

## **Scoring methodologies**

49 of the 50 questions relating directly to patient experience have been summarised as the score of the percentage of patients who reported a positive experience. For example:

- question 6 asks: "Overall, how did you feel about the length of time you had to wait for your test to be done?". Responses have been recorded as positive only for those patients who selected the first option ("It was about right")
- question 11 asks: "When you were told you had cancer, were you given written information about the type of cancer you had?". Responses have been recorded as positive only for those patients who selected the first option ("Yes, and it was easy to understand").

Where options do not provide any information on positive/negative patient experience (e.g. "Don't know / can't remember"), they are excluded from the score.

The other question (question 59) asks respondents to rate their overall care on a scale of 0 to 10. Scores have been given as an average on this scale.

## **Case-mix adjustment**

For the first time in 2015, case-mix adjusted findings are being presented alongside unadjusted results for CCGs. Case-mix adjustment allows us to account for the impact that differing patient populations might have on results. By using the case-mix adjusted estimates we can obtain a greater understanding of how a CCG is performing given their patient population.

The factors taken into account in this case-mix adjustment are gender, age, ethnic group, deprivation, and tumour group.
